- 1. Period of contract: ONE** year from the date of agreement, which can be extended further up to a period of one year on the same terms and conditions.
- 2. Purchase of Tender document: e-Tender** document can be obtained by downloading it from the website www.eprocure.gov.in. The physical copy of the Tender document would not be available for sale.

The Tender fee should be paid in the form of Crossed Demand Draft / Bankers Cheque issued by any Nationalized /Scheduled Bank in favour of **“BSNL Parbhani** . OR

Tender Fee Can also be paid by cash payment to the Accounts Officer (Cash), at Cash – COUNTER, 2nd floor , Telephone Bhavan , Parbhani between 10:30hrs. to 13:00 hrs on all working days. **Original Cash Receipt shall be produced.**(iii) **The Tender fee is non- refundable & non-transferable.**

- 3. Bid Security/EMD:** The bidder shall furnish the bid Security / EMD in the form of Demand Draft/ Banker’s cheque issued by any Nationalized /Scheduled Bank drawn in favour of “Accounts Officer (Cash), BSNL, O/o GMT, Parbhani” OR in form of Bank Guarantee from a Nationalised/scheduled bank drawn in favour of “The A.G.M.(ADMIN), O/o the GM, BSNL, PARBHANI” which should be valid for 180 days from the tender opening date OR also can be paid in cash.

4. **Exemption from payment of Tender Security (EMD):** Micro & Small enterprise units registered with District Industries Centre or Khadi & Village Industries Commission or Khadi & Village Industries Board or National Small Scale Industries (NSIC) or Directorate of Handicrafts & handloom or any other body specified by Ministry of Micro, Small & Medium Enterprises will be exempted from payment of Tender Fee and Bid Security (EMD) subject to production of valid registration certificate copy. Please refer detailed terms and conditions given in **Section-VII**.

5. **Eligibility Criteria:**

The firm should have the registration under PSARA [Private Security Agency (Regulation) Act] and it should produce the valid PSARA License/Registration Certificate along with the bid.

Experience: The contractor must have successfully completed works of similar nature as defined in scope of work section XII of the tender document supply of manpower for watch and ward works in BSNL/DOT/Nationalized or Scheduled Banks/PSUs [State/Center], costing an amount not less than 35% of tender cost during the last three financial years, including the current financial year up-to the date of DNIT. Experience certificate should be issued by officer not below the rank of DGM in case of experience in BSNL/DoT/MTNL. In case of Banks (Nationalized/Scheduled) /PSUs [State/Center] Experience certificate issued by the competent authority [e.g. Regional AGMs or other authorised officer(s)]. The Name/Designation, Telephone No. & E-Mail ID in respect of the authority issuing the Experience Certificate should have been clearly mentioned on the experience certificate, so that if the verification/confirmation of issue of experience certificate is felt essential the same can be obtained without undue delay.

Turn over certificate: The turn over certificate issued by the chartered accountant. Average annual financial turnover should not be less than 30% of the estimated value, in last three financial years.

6. **Last Date & Time of submission of on-line tender: On 16/10/2018 up to 13.00Hrs.**
7. **Date & Time Opening of on-line tender: On 17/10/2018 at 15.00 Hrs.**
