7) BID SECURITY / EMD	The bidder shall furnish the bid Security / EMD in a following way:- a) Demand Draft/ Banker's cheque issued by any Nationalized Nationalized/Scheduled Bank drawn in favor of "The Accounts Officer (Cash),O/o TDM Wardha between 11:30hrs. to 12:30 hrs on all working days". Or b) Bank Guarantee from a Nationalized/Scheduled Bank OR Fixed Deposit Receipt drawn in favour of " <u>The TDM, BSNL, Wardha-442001</u> " which should be valid for <u>180</u> days from the tender opening date.
8) Eligibility Conditions	The prospective bidder should satisfy following conditions:- 1. The bidder should have at least One year experience certificate of satisfactory performance in similar services preferably with Government. Public Sector or reputed Private Ltd. Companies/Firms. 2. The bidder should own or have on company lease sufficient number of commercial vehicles registered as taxis not less than 2 (i.e. minimum 16-67% of the total quantity estimated for hiring) with permit from RTOs in the name of proprietor/ company/ partners/ firm / director, and not older than five years from the date of issue of NIT. The full details of the vehicles and a clear declaration that the firm will be able to supply commercial vehicles of model not older than 5 (Year) shall be provided.
9) Registration of firm	Copy of certificates of incorporation/copy of Registration of firm /copy of valid shop act license OR Copy of Partnership deed in case of partnership firm OR Copy of Memorandum and Article of Association in case of limited company OR Joint venture agreement and registration certificate of constitute companies in case of joint venture companies.

Moreover, they should also produce documentary evidence showing that the firm is registered with NSIC for the item tendered for.
